**Volunteer Service Explanation:**

Our association cannot operate without the many people who selflessly give their time and talents to make it a success. In the past we have required members to be willing to help out with at least one task during the year if they are called on. In fact, during any given year, many people are never called. By indicating your preference(s) on this form you are indicating your willingness to serve and giving us a place to start looking when we need help. However, we have come to realize that not everyone is willing to give even a small amount of time to the association, so we now offer a second option.
